- A. All information shall be typed or printed in black or blue ink, **AND APPLICATION MUST BE NOTARIZED.**
- B. Submit the application, upon completion, to the county treasurer, or in any home rule county or city of the first class, where there is no elected treasure, to the designee of the governing authority.
- C. There is no fee for a special permit.
- D. The application shall be signed by the executive officer or secretary of the association.
- E. The association must have existed and conducted business in furtherance of its written constitution, charter, articles of incorporation or express purpose for two years prior to applying for a license, and such documentation must accompany initial application.

Exception: An association whose membership consists exclusively of elderly residents of a senior citizen housing project may apply for a license immediately after it is organized.
